Itinerary for Turin, Assisi, Rome & More

May 11, 2010 **Depart USA for Turin, Italy** Flight from USA to Turin, Italy

May 12, 2010 **Turin** Upon arrival at the airport you will be met by Steve and Janet Ray and your Italian tour escort and transferred to your hotel in **Turin**. Welcome dinner hosted by Steve and Janet Ray. Overnight in **Turin**.

May 13, 2010 **Shroud of Turin Mass**, then enjoy a full day tour of **Turin** and visit to the **Holy Shroud**. During our tour of Turin we will see Piazza San Carlo, Po Street, and Mount of the Capuchin Monks. We then have the opportunity to view the Shroud of Turin in St. John the Baptist Cathedral. The Shroud of Christ is a linen cloth 14 feet, 3 inches long by 3 feet, 7 inches wide bearing the distinct image of a crucified man. The last time the shroud was displayed publicly was during the Jubilee Year of 2000 and was not originally due to be displayed again until 2025. Our Holy Father, Pope Benedict XVI, has authorized it to be displayed for a brief period in 2010. We will have what is perhaps a once-in-a-lifetime opportunity (literally) to view the Shroud. Return to the hotel in the late afternoon. Dinner and overnight in **Turin**.

May 14, 2010 **Turin/Assisi** Early departure for **Assisi**, home to St. Francis and St. Clare. Assisi. The destination of millions of pilgrims each year, has remained peaceful and unspoiled throughout the ages. At the foot of the town, we will stop for **Mass at St. Mary of the Angels Basilica** which encloses the small chapel that St. Francis built (the Porziuncola, or "little portion".) The Basilica also houses the Cappella del Transito that contains the cell where St. Francis died in 1226. Flanking the cell is the Thornless Rose Garden. Dinner and overnight in **Assisi**.

May 15, 2010 **Assisi Mass at St. Clare**. Guided visits today of St. Francis Basilica, San Rufino where St. Francis and St. Clare were both baptized and St. Clare to see the cross that spoke to St. Francis and led him to a life of piety. Free time in the afternoon and evening. Dinner and overnight in **Assisi**.

May 16, 2010 **Assisi/San Giovanni Rotondo** Drive down the **Adriatic Coast** to the great **Marian Shrine of Loreto**, to visit the Holy House of Nazareth and the beautiful Madonna of Loreto. More than 50 popes have made a pilgrimage to the house transported by angels to this hill in central Italy in 1294. Tradition has it that this is the house in which Mary first prayed the Magnificat, in which Jesus grew to manhood, and in which the Holy Family live. Continue to **Lanciano** where we will **Mass at the little Church Lagontial and see the Eucharistic Miracle**. Later this evening we will arrive **San Giovanni Rotondo**. Dinner and overnight in **San Giovanni Rotondo**.

May 17, 2010 **San Giovanni Rotondo** After **Mass at the tomb of Padre Pio**, we tour the sanctuary, see the old church and the crucifix from which he received the stigmata in 1918. You will see the confessional where Padre Pio spent innumerable hours with a multitude of pilgrims, directing them on their journey toward God. Enjoy a breathtaking view of the Gargano Peninsula and a visit to the Grotto of Michael the Archangel. Six different popes, St Francis and at least four other saints have knelt in prayer at this grotto, seeking the protection of St Michael. Return to the hotel for dinner and overnight.

May 18, 2010 **San Giovanni Rotondo/Rome** Depart for Rome. Upon arrival **Mass and visit the catacombs of St. Sebastian**. The 4th century catacomb was named for the saint who was buried here. Sts. Peter and Paul were buried here for a time. Along the way on the Via Appia Antica we will see the small Church Domine Quo Vadis. Dinner at a local restaurant. Overnight.

May 19, 2010 **Rome** Attendance at the weekly Papal Audience this morning (pending the Holy Father's schedule). In the afternoon we depart for a sightseeing tour with focus on "Christian Rome." See many important cultural and monumental sights around Rome. Stop for a visit at three major Basilicas: St Mary Major, one of the oldest shrines dedicated to the Blessed Virgin, a shrine that contains a relic from the manger of the infant Jesus. The Basilica of the St John in Lateran, is the former residence of the popes prior to their return to Rome in 1377. **Mass at St Paul Outside the Walls**, which houses the remains of St Paul under its main altar. Farewell dinner at a local restaurant. Overnight in Rome.

May 20, 2010 **Main Tour departs to USA/Rome Extension begins** *Main Shroud of Turin Tour:* Depart for return flight to USA; *Rome Extension:* Take a tour this morning of Ancient Rome including the Roman Forum and the Coliseum (inside visit). Descend into the Mammertine Prison where Peter and Paul were imprisoned (if open). Finish the morning with **Mass at St. Peter in Chains Church** to see the chains that bound St. Peter and Michelangelo's famous Moses. Late afternoon, enjoy a Piazza walking tour, including the Pantheon, Trevi Fountain, and the Church of St. Ignatius. Dinner and overnight.

May 21, 2010 **Rome Extension Mass at St. Peter's Basilica**. Take a guided tour of the Vatican Museum and the Sistine Chapel, where you will view some of the most inspiring works of art, including Michelangelo's magnificent fresco of the Last Judgment. Afternoon at leisure. Dinner and overnight

May 22, 2010 **Rome Extension** This morning, we will visit San Clemente Church with four levels of Roman history underground. Under the high altar of the bones of two Apostolic Fathers-- Ss. Ignatius of Antioch and Clement of Rome. Then **Mass at St. Stefano Rotondo**, surrounded by paintings of the saints being martyred. It is one of Steve's favorite churches in the world. Afternoon and evening at leisure or Steve and Janet will lead an optional walking tour in Rome visiting the Church of St. Augustino, the Piazza Navona and more. Dinner and overnight in Rome.

May 23, 2010 **Rome/USA** After breakfast, we will check-out of our hotel and be transported to Rome for our flight.

TERMS & CONDITIONS

PAYMENT: In order to meet deposit schedules with suppliers for this tour, Corporate Travel Service asks for prompt payment on the requested dates. Please see the reservation form for the payment schedule. The advertised price is based on 50 passengers, tariffs, exchange rates, air line fuel surcharges and taxes in effect when the tour was organized and are subject to increase before tour departure. Price of the tour may have to be adjusted before final payment to reflect any increase in tariffs, fluctuation in exchange rates and/or fuel surcharges.

Corporate Travel Service accepts cash, check, money orders and Visa and MasterCard for payment. In order to qualify for the advertised price, traveler must pay entire tour (deposit and final payment) by cash or check. The discount for payment by cash or check will be made after final payments are received.

CANCELLATION POLICY: All cancellations must be received in writing. Cancellations received before December 12, 2009 will forfeit \$100 per person. Forfeit \$350 deposit between December 12, 2009 and January 31, 2010. Forfeit \$1600 for cancellations received between January 31, 2010 and February 25, 2010. After February 25, 2010, no refund. **Penalties will be according to the fax or postmark date.**

STATE DEPARTMENT & OTHER AGENCIES: From time to time the State Department (www.state.gov) and the Centers for Disease Control (www.cdc.gov) and other government agencies and departments issue travel advisories or warnings for one or more of the destinations that you may be visiting on tour. We encourage you to contact these agencies directly to obtain the most current information. Corporate Travel Service cannot change the cancellation terms or conditions based on the issuance of any such warning or advisory or the occurrence of any terror, health or other incident in one or more of the places this tour is scheduled to visit. All cancellation penalties must remain in full force and effect as outlined on the reservation form.

ROOMS: Tour prices are per person according to a room type: a "Single" room is one person in a room and a "Double" is two persons in one room. "Triple" rooms are discouraged because of cramped quarters. Triples are one double bed with two persons sharing the bed and one single bed. Triples are not always available. Single rooms are limited in Israel and are available first come-first served until the supply is exhausted.

CHECKED LUGGAGE: Checked baggage is limited to one bag per person. There can be no exceptions. For most airlines, the one checked bag is limited to **50 pounds and 62 inches** (length + width + height). If these specifications are exceeded, excess charges may be collected by the airline at the airport. Do not lock baggage you intend to check in at the airport. Please confirm these specifications when you receive your final travel documents, as they can and do change.

CARRY ON LUGGAGE: You may also bring a small carry-on bag that will fit under an airline seat and on the small parcel racks of the motor coach, which average about 8 inches high by 18 inches deep. It is best if your carry-on bag is soft sided, as the parcel racks on the motor coaches are small. Currently, travellers are allowed to transport only small amounts of liquids, gels, lotions, aerosols or similar items on their person or in their carry-on luggage. Details will be in your final travel documents.

GRATUITIES: Gratuities for your escort, driver and guides are included.

PASSPORT AND VISA: A valid U.S. Passport is required of all passengers. Please apply for your passport immediately as passports are taking a long time to process. Make sure to have it in your possession at all times while on tour. **It must be valid for 6 months following the return date of the trip or boarding may be denied or entry into the destination may be forbidden.**

GROUP AIR: Due to the airlines' reduced capacity and restrictive group reservation terms, group air reservations are often difficult to coordinate. The number of connections, length of layovers, and all conditions surrounding air travel cannot be guaranteed and may change before departure. Accordingly, if you require specific air travel needs and are not flexible concerning group air travel, **you may wish to consider purchasing a Land-Only package** and secure your own preferred air arrangements. In this case, you must notify Corporate Travel Service no less than 120 days before departure, be responsible for meeting the group at a specified location and time on the tour, and sign a Corporate Travel Service Land Only Waiver. Land only passengers are responsible for arranging and the cost of transfers to and from the airport. Corporate Travel Service will not be responsible for any loss incurred by traveller due to a cancelled flight or other means of transportation. DOMESTIC AIR TO NEW YORK: You are responsible for your own air arrangements to New York. You will be notified of the international gateway airport (JFK or EWR) about 60 days prior to departure. **Do not buy domestic air before hand.**

TRAVEL DOCUMENTS: Unless otherwise notified, Corporate Travel Service will mail to you or your group leader a more detailed itinerary and General Information Sheet approximately 2 weeks or 10 days before departure.

ITINERARY: The Itinerary as presented in this brochure is tentative and represents what we are planning for you, however it is subject to confirmations from many organizations. Because of changes in local schedules, we may need to alter specified events, dates and/or venues to better fit the overall plan.

HEALTH REQUIREMENTS: Travellers must be medically and physically fit for this tour. This tour requires significant walking, as motor coaches are not permitted to pick up and drop off in front of major attractions. The tour is not wheelchair accessible. Any special medical conditions or equipment must be advised in writing, for evaluation of feasibility, at the time of making your reservation.

CHILDREN UNDER 18: For a minor under the age of 18 to travel out of the United States without both parents or legal guardians, a notarized affidavit must be obtained and presented to immigration official upon departure and return to the United States. You may request a form from our office. *Children must be at least 6 years old to travel.*
