## Tentative Ave Maria Singles Lourdes & Fatima Itinerary\*

### Wednesday, March 10, 2010 Depart USA

Depart on international flight to Toulouse. Passengers make flight arrangements on their own. Airport transfer will be made at 10 am and 2 pm. Plan your flights to arrive at **least one hour prior** to these transfer times to allow time to clear Customs. Our Retail Travel Agency will be happy to assist with your air arrangements.

### Thursday, March 11, 2010 Arrive Toulouse/Lourdes, France

Arrival at Toulouse airport, meet your Faithful Catholic European Escort and transfer to Lourdes. ***Celebrate Mass at the famous Grotto.*** Dinner on your own. Overnight in Lourdes

### Friday, March 12, 2010 Lourdes (CB, D)

***Celebrate Mass***, then walk in the footsteps of St. Bernadette. See Boly Mill, where St. Bernadette was born, and the Cachot, an abandoned prison where Bernadette's impoverished family lived. Join your prayers with those of pilgrims from around the world as you pray for the sick and drink water from the miraculous spring. Experience Christ's love as you walk the life-sized Stations of the Cross overlooking the holy Grotto. Kneel in the chapel built on the very rock of the Grotto, in obedience of the request of the Immaculate Conception. Attend the blessing of the sick and participate in the nightly candlelight procession requested by Our Lady. Welcome Dinner and overnight in Lourdes.

### Saturday, March 13, 2010 Lourdes/Loyola (CB)

Depart Lourdes for Spain through the scenic area of the Pyrenees Mountains. Visit the lovely village of Loyola, the birthplace of St. Ignatius of Loyola. See the sanctuary where a magnificent basilica adjoins a 13th century tower house where St. Ignatius was born. ***Celebrate Mass in the Chapel of Conversion in Loyola.*** It was here St. Ignatius experienced a profound conversion when the Blessed Mother appeared to him. Later in his life, St. Ignatius renounced his portion of his family's wealth and founded the Society of Jesus. St. Ignatius wrote the Spiritual Exercises, which consist of meditations, prayers and mental exercises. Dinner on your own. Overnight in Loyola at a guesthouse or hotel.

### Sunday, March 14, 2010 Loyola/Burgos (CB)

Drive to Burgos with afternoon arrival. Take a city tour of Burgos, along the Saint James Way pilgrimage route. Burgos still possesses more ecclesiastical monuments than any other Spanish city, which are the monastery of Las Huelgas, the Carthusian monastery of Miraflores and the Cathedral, with its chapel of the Condestables de Castilla. Tour the 13th century Cathedral, with its portal, the "Puerta del Sarmental," considered the best example of Gothic sculpture of its century. ***Celebrate Mass at the Cathedral, the third largest church in Spain.*** Dinner on your own. Overnight in Burgos.

### Monday, March 15, 2010 Burgos/Leon/Santiago de Compostela (CB)

Depart Burgos and journey to the city of León. León is famous for its Gothic Cathedral with its excellent stain-glassed windows and monumental buildings, such as the Real Colegiata de San Isidoro. ***Celebrate Mass at the Church of St. Isidoro.*** Then, onto Santiago de Compostela, crossing the River Sil, with beautiful landscapes. Dinner on your own. Overnight in Santiago de Compostela.

### Tuesday, March 16, 2010 Santiago de Compostela (CB)

This morning, visit the beautiful cathedral in Santiago de Compostela, the town of St. James. ***Take part in the morning Pilgrim Mass*** when the swinging "botafumeiro" is celebrated. The "botafumeiro" is a three-foot high iron incense burner that is suspended by a two hundred-foot rope and swung over the heads of the congregation. An impressive feature of the cathedral is the Portico de la Gloria, which is located just inside the main entrance. Through the centuries, millions of pilgrims have touched the central pillar. After a thousand years of embracing and touching, the stone has been left smooth and worn. The relics of St. James, the Apostle, repose in the high altar. Pilgrims can follow the centuries-old tradition of climbing the stairs behind the altar to kiss the shells that rest on the golden statue of the saint. Below the statue is the crypt that contains the bones of St. James in a silver reliquary. Dinner on your own. Overnight at Santiago de Compostela.

### Wednesday, March 17, 2010 Santiago de Compostela/Bom Jesus/Fatima, Portugal (CB)

Cross the border into Portugal, via the Province of Minho. A stop will be made in Braga to visit the Sanctuary of Bom Jesus do Monte, Portugal's most photographed church. Then travel on to Fatima. ***Celebrate Mass in Fatima.*** Dinner on your own. Overnight in Fatima.

### Thursday, March 18, 2010 Fatima (CB)

Full day tour of Fátima, one of the most important Marian Shrines in the world. ***Celebrate Mass at the Chapel of Apparitions.*** Next, see the hamlet of Aljustrel, where the children lived and Valinhos, the site of Our Lady's appearance after the children's return from prison. Follow the Stations of the Cross along the Via Sacra (The Sacred Way), built by Hungarian refugees, that culminates in the Chapel of Calvary, which overlooks all of Fatima. Visit the church where the children were baptized. The rest of day will be free for private devotions. Dinner on your own. Overnight Fatima.

### Friday, March 19, 2010 Fatima/Lisbon (CB, D)

Departure to Lisbon, the capital of Portugal. ***Celebrate Mass at St. Anthony's Church.*** Panoramic tour of Lisbon, including the majestic quarter of Belem and its landmarks: the Belem Tower, the Jeronimos Monastery, the most important religious monument in the country, and the Monument to the Discoveries. Tonight, our Farewell Dinner will be held at one of the famous Fado restaurants of Lisbon, where we will enjoy a live show with Fado music and Portuguese folklore dances. Overnight in Lisbon.

### Saturday, March 20, 2010 Return to USA

Return flight to the USA (flight arrangements on your own) Airport transfers will be: 5 am, arriving airport at 5:30 am; 7:30 am, arriving airport at 8 am. Make sure to book flights to coincide at least 2 hours after your arrival time at the airport.

# **TERMS & CONDITIONS**

**PAYMENT:** In order to meet deposit schedules with suppliers for this tour, Corporate Travel Service asks for prompt payment on the requested dates. Please see the reservation form for the payment schedule. The advertised price is based on a minimum of 55 passengers, tariffs, exchange rates, air line fuel surcharges and taxes in effect when the tour was organized and are subject to increase before tour departure. Price of the tour may have to be adjusted before final payment to reflect any increase in tariffs, fluctuation in exchange rates and/or fuel surcharges.

Corporate Travel Service accepts cash, check, money orders and Visa and MasterCard for payment. In order to qualify for the advertised price, traveler must pay entire tour (deposit and final payment) by cash or check. The discount for payment by cash or check will be made after final payments are received.

**CANCELLATION POLICY:** All cancellations must be received in writing. Forfeit \$100 per person for cancellation received before October 11, 2009. Forfeit \$350 for cancellations received between October 11, 2009 and November 30, 2009. Forfeit \$1,600 for cancellation received between November 30, 2009 and December 24, 2009. After December 24, 2009, no refund. **Penalties will be according to the fax or postmark date.**

**STATE DEPARTMENT & OTHER AGENCIES:** From time to time the State Department ([www.state.gov](http://www.state.gov)) and the Center for Disease Control ([www.cdc.gov](http://www.cdc.gov)) and other government agencies and departments issue travel advisories or warnings for one or more of the destinations that you may be visiting on tour. We encourage you to contact these agencies directly to obtain the most current information. Corporate Travel Service cannot change the cancellation terms or conditions based on the issuance of any such warning or advisory or the occurrence of any terror, health or other incident in one or more of the places this tour is scheduled to visit. All cancellation penalties must remain in full force and effect as outlined on the reservation form.

**CANCELLATION INSURANCE:** Corporate Travel Service HIGHLY RECOMMENDS the purchase of travel insurance. In order to receive the optimum insurance coverage, purchase travel insurance within 14 days of deposit. Call Corporate Travel Service at 313-565-8888, ext. 151 or 152.

**ROOMS:** Tour prices are per person according to a room type: a "Single" room is one person in a room and a "Double" is two persons in one room. "Triple" rooms are discouraged because of cramped quarters. Triples are one double bed with two persons sharing the bed and one single bed. Triples are not always available.

**CHECKED LUGGAGE:** Checked baggage is limited to one bag per person. There can be no exceptions. For most airlines, the one checked bag is limited to **50 pounds and 62 inches** (length + width + height). If these specifications are exceeded, excess charges may be collected by the airline at the airport. Do not lock baggage you intend to check in at the airport. Please confirm these specifications when you receive your final travel documents, as they can and do change.

**CARRY ON LUGGAGE:** You may also bring a small carry-on bag that will fit under an airline seat and on the small parcel racks of the motor coach, which average about 8 inches high by 18 inches deep. It is best if your carry-on bag is soft sided, as the parcel racks on the motor coaches are small. Currently, travellers are allowed to transport only small amounts of liquids, gels, lotions, aerosols or similar items on their person or in their carry-on luggage. Details will be in your final travel documents.

**GRATUITIES:** Gratuities for your escort, driver and guides are not included. In Europe it is customary to tip the escort (3) Euros and the driver two (2) Euros per person per day. The tip for the local guides is usually about one (1) Euro for half-day tours and two (2) Euros for full day tours

**PASSPORT:** A valid U.S. Passport is required of all passengers. Please apply for your passport immediately as passports are taking a long time to process. Make sure to have it in your possession at all times while on tour. **It must be valid for 6 months following the return date of the trip or boarding may be denied or entry into the destination may be forbidden.**

**GROUP AIR:** Not included in the price. This trip is offered land only. **Do not purchase Trans-Atlantic airfare until notified in writing that there are enough participants registered to operate this pilgrimage.** Corporate Travel's Retail Agency will be happy to assist in arranging your flights.

**DOMESTIC AIR TO NEW YORK:** You are responsible for your own air arrangements to New York. You will be notified of the international gateway airport (JFK or EWR) about 60 days prior to departure. Do not buy domestic air before hand.

**TRAVEL DOCUMENTS:** Unless otherwise notified, Corporate Travel Service will mail to you or your group leader a more detailed itinerary and General Information Sheet approximately 2 weeks or 10 days before departure.

**ITINERARY:** The Itinerary as presented in this brochure is tentative and represents what we are planning for you, however it is subject to confirmations from many organizations. Because of changes in local schedules, we may need to alter specified events, dates and/or venues to better fit the overall plan.

**HEALTH REQUIREMENTS:** Travellers must be medically and physically fit for this tour. This tour require significant walking, as motor coaches are not permitted to pick up and drop off in front of major attractions. The tour is not wheelchair accessible. Should any special assistance be required, traveller agrees to bring a companion capable and willing to assist traveller.

**CHILDREN UNDER 18:** For a minor under the age of 18 to travel out of the United States without both parents or legal guardians, a notarized affidavit must be obtained and presented to immigration official upon departure and return to the United States. You may request a form from our office.
